1. We require **5 ml serum** or, alternatively, 14 ml blood.  
Samples should be filled into serum monovettes.
2. Samples of plasma, EDTA blood or blood in heparinized vials are **not** suitable.
3. The vials have to be encased in plastic containers.  
These are available from medical laboratories or pharmacies.
4. Vialled samples need **not** be frozen or shipment.
